In consideration of being allowed to participate in any way in the Bay Area Canoe and Kayak Club) meeting, fishing Event and its related competition and activities (EVENT), I, the undersigned (or Participant), being under the age of 18, acknowledge, appreciate, and agree that:

1. I affirm that my participation in any EVENT is voluntary and declare that I will follow EVENT rules, I am physically fit and capable to participate in such; and
2. I acknowledge that kayak fishing participation and competition involves certain inherent dangers, and hazards; that the risk of injury from the activities involved in this event is significant, including the potential for permanent paralysis and death, and while particular skills, physical fitness, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
3. Participant (and Adult Parent, Guardian, or Designated Adult Supervisor) KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for Participant's participation; and,
