**Bay Area Canoe, Kayak Fishing Club (B.A.C.K.)**  
**Individual Membership General Release and Waiver of Liability**

In consideration of being allowed to participate in any way in a Bay Area Canoe and Kayak Club meetings, fishing, events and any related competition and activities (EVENT), I, the undersigned (or member), being at least 18 years of age, acknowledge, appreciate, and agree that:

1. I affirm that my participation in any EVENT is voluntary and declare that I will follow EVENT rules, I am physically fit and capable to participate in such; and
2. I acknowledge that kayak fishing participation involves certain inherent dangers, and hazards; that the risk of injury from the activities involved in this event is significant, including the potential for permanent paralysis and death, and while particular skills, physical fitness, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
3. I (KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
4. I willingly agree to comply with the stated and customary Terms and Conditions for Participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and immediately bring such to the attention of BACK Officers or Directors; and,
